 - Mountain Comp travels to businesses, churches, and other locations to conduct covid vaccine clinics in local neighborhoods
- COVID testing
 - Across state
 - Park DuValle in Louisville
 - Rural health clinic locations in west Ky
- COVID Care Coordination
 - Cumberland Family Medical Centers- found that a lot of people testing positive for COVID did not have a primary care provider and did not know what to do or what to expect after testing positive
 - One-on-one counseling and support for those patients—guiding them through the process, and connecting them to resources after they tested positive for COVID.
